JOB APPLICATION PRIVACY NOTICE

American Medical Technology, Inc. ("AMT" or "we" or "us" or "our") thanks you as a job applicant ("You" or "Your") for Your interest in pursuing a career at one of our owned entities: Applied Medical Technology, Inc. ("Applied") or Auxano Medical, LLC ("Auxano"). AMT values Your privacy and trust and therefore is committed to taking steps to responsibly monitor and protect Your personal information. This Job Application Privacy Notice ("Notice") describes AMT's practices in connection with the information AMT receives from You online through the submission of Your job application with Applied or Auxano's website (each and collectively a/the "Website").

I. Information AMT Collects

When You access or use our Website to submit a job application, in addition to that which notice is given in our Privacy Policy, we may collect the following:

- <u>Device Information</u>: If applicable and related to devices used to access the Website, device model, device settings, or device location.
